CONTRACT TO PARTICIPATE IN MOTOR SPORT / ACTIVITY AND/OR FACILITIES.

HEREBY AGREE with the persons, organizations and bodies corporate, whose names appear in Schedule 1 (hereinafter collectively call "the organizer"), that I am by this agreement, entitle to participate in the Motorcycle activity /meeting listed in Schedule 2 (hereinafter called "the activity"). At the venue listed in Schedule 3 (hereinafter called "the venue") under the terms and conditions set out in this document.

2. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I/we ACKNOWLEDGE that: motorcycle sport is dangerous and that by engaging in the sport and participating in the sport or activity, 1/we take and am exposed to certain risks and dangers and am under certain obligations as follows:

- a) that I/we may be injured, physically or mentally, and may be killed;
- b) that my/our machinery or equipment may be damaged, lost or destroyed;
- c) that competitors may ride dangerously or with a lack of skill;
- d) that track or event conditions may be hazardous and may vary without warning or predictability;
- that organisers, and any agents or representatives of those in charge of activities, are frequently obliged to make decisions under pressure of time/or events;
- f) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- h) that I have an obligation to myself and to others to act safely and within the rules of competition.

3. INDEMNITY AND RELEASE GIVEN TO ORGANISERS
